

Indemnity vs. Medical



Indemnity vs. Medical



Lost-Time Claims, per \$ Million of On-Leveled Premium



Adjusted to Common Wage Level vs. Actual, in \$ Thousands




Average Voluntary Pure Loss Costs



Lost-Time vs. Medical-Only, per 100,000 Workers



PY 2018 vs. PY 2019, in \$ Thousands





PY 2018 vs. PY 2019, in \$ Thousands



Alaska Distribution of Claims by Injury Type






Alaska Indemnity Loss Distribution by Injury Type


