Total Benefit Costs in South Dakota

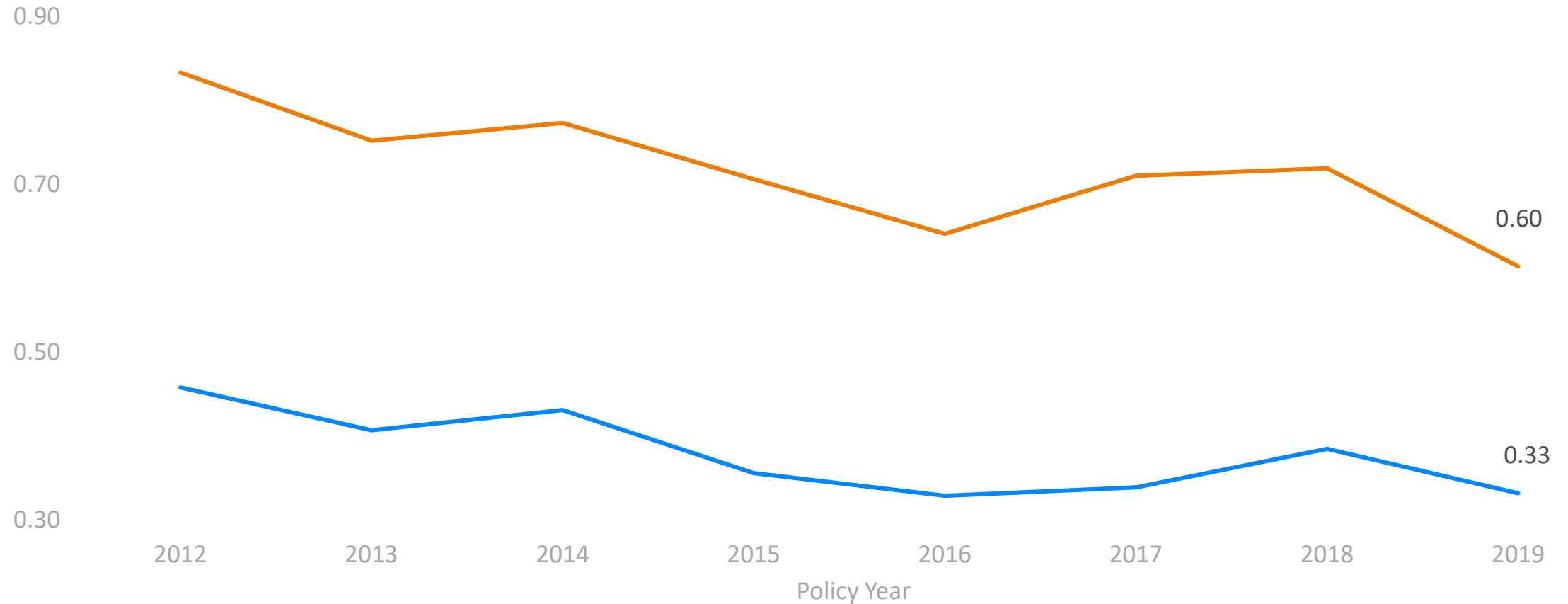

Indemnity vs. Medical

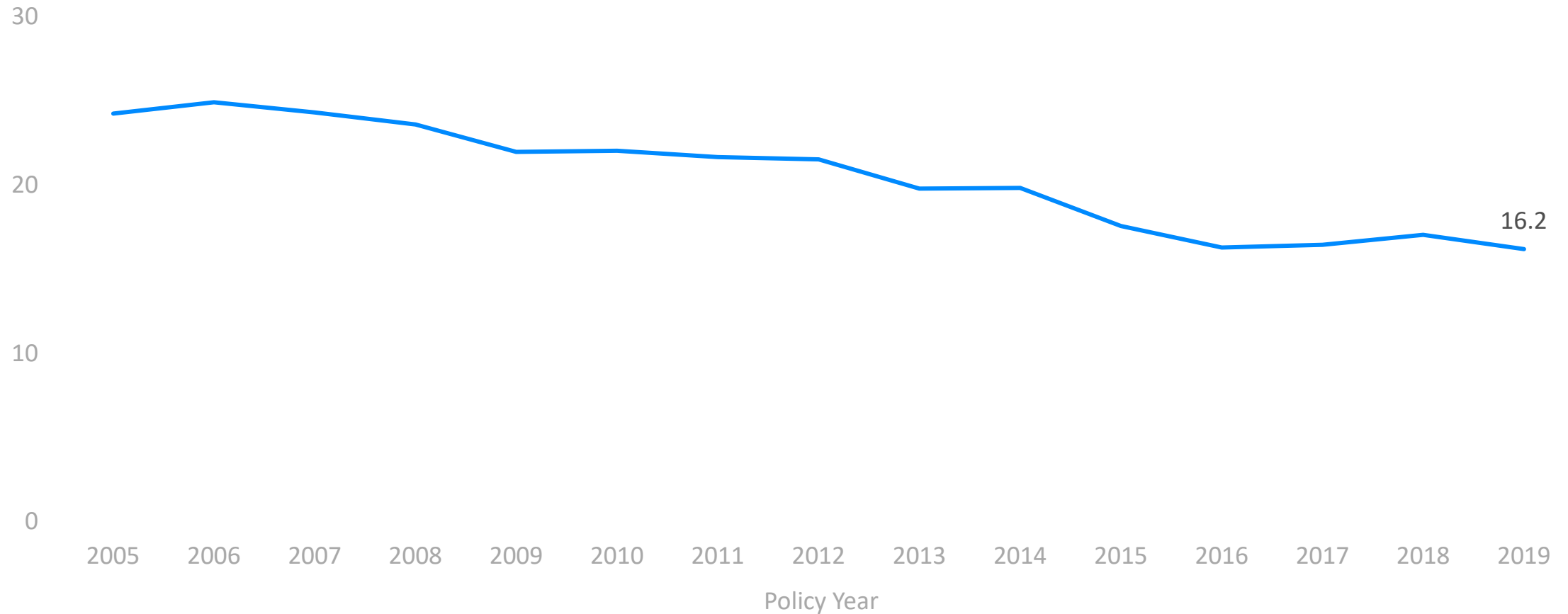

Lost-Time Claims, per \$ Million of On-Leveled Premium

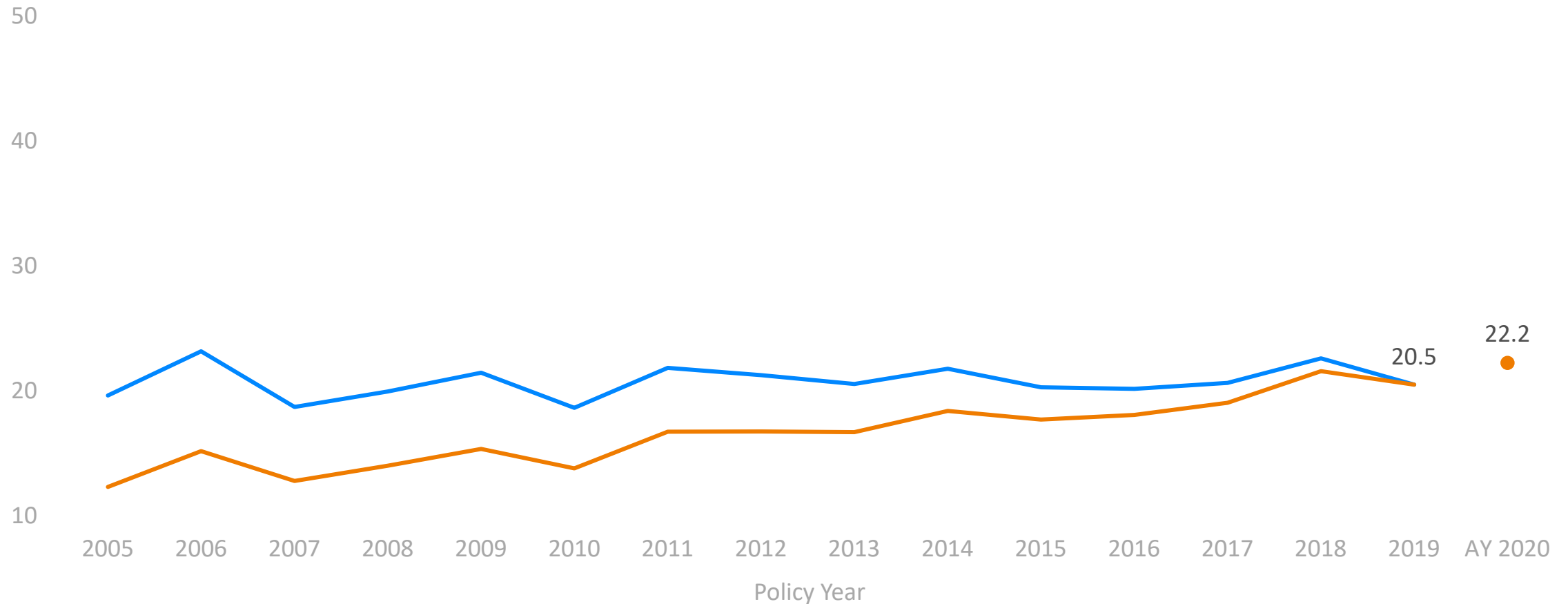

South Dakota Average Indemnity Claim Severity

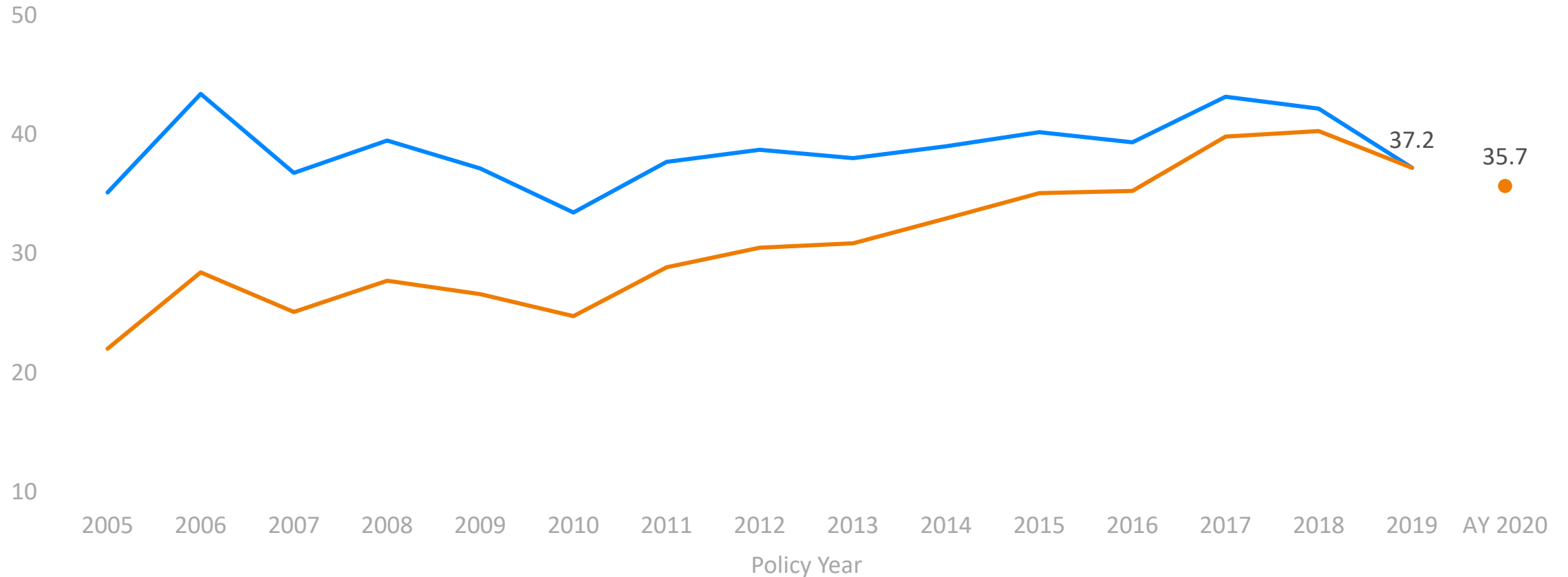
Adjusted to Common Wage Level vs. Actual, in \$ Thousands

Adjusted to Common Wage Level vs. Actual, in \$ Thousands

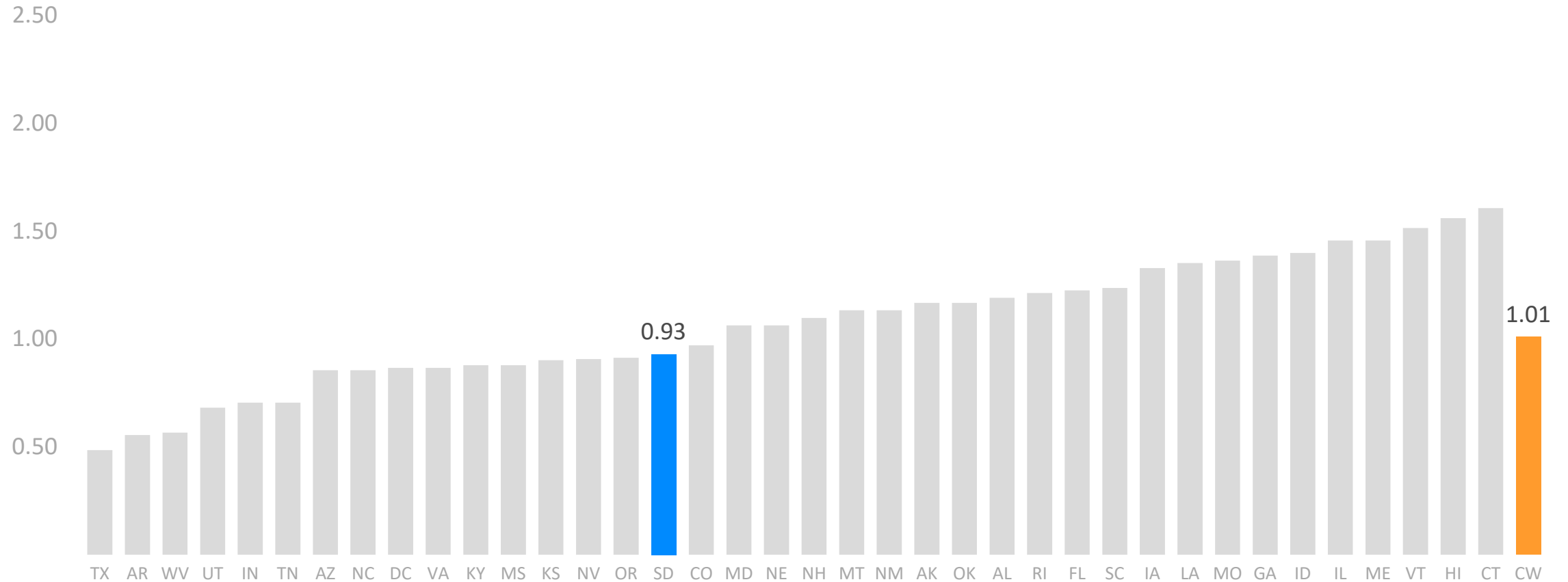

Using South Dakota Payroll Distribution

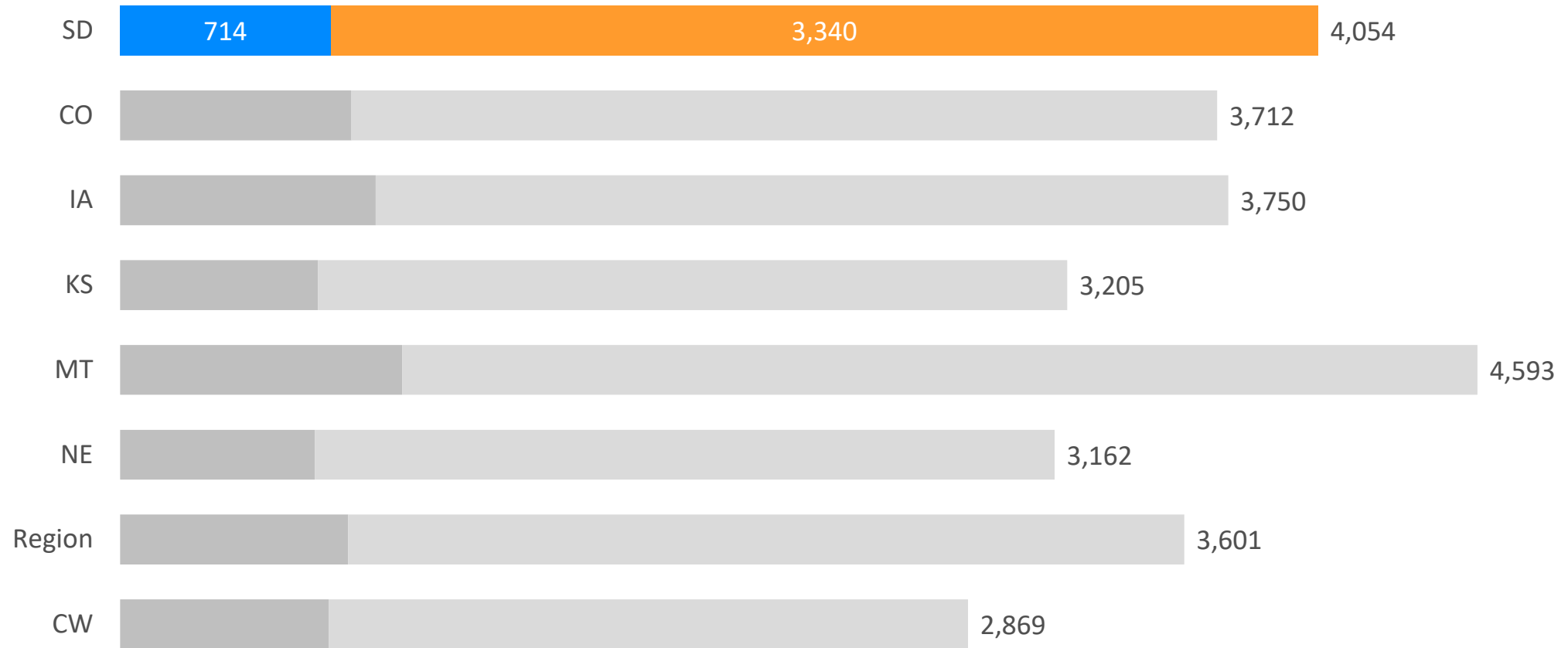

Lost-Time vs. Medical Only, per 100,000 Workers

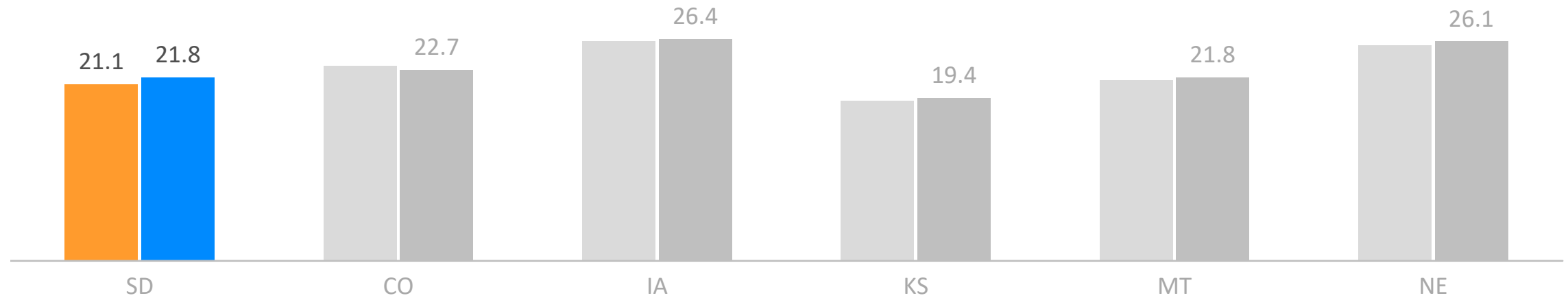

Average Indemnity Claim Severity in the Region

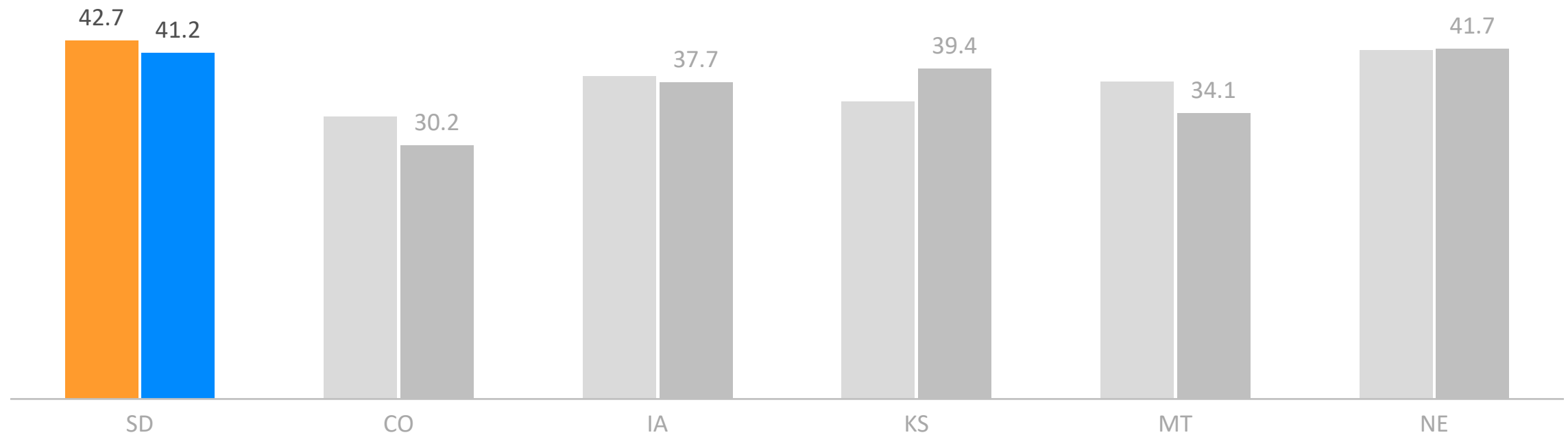
PY 2017 vs. PY 2018, in \$ Thousands

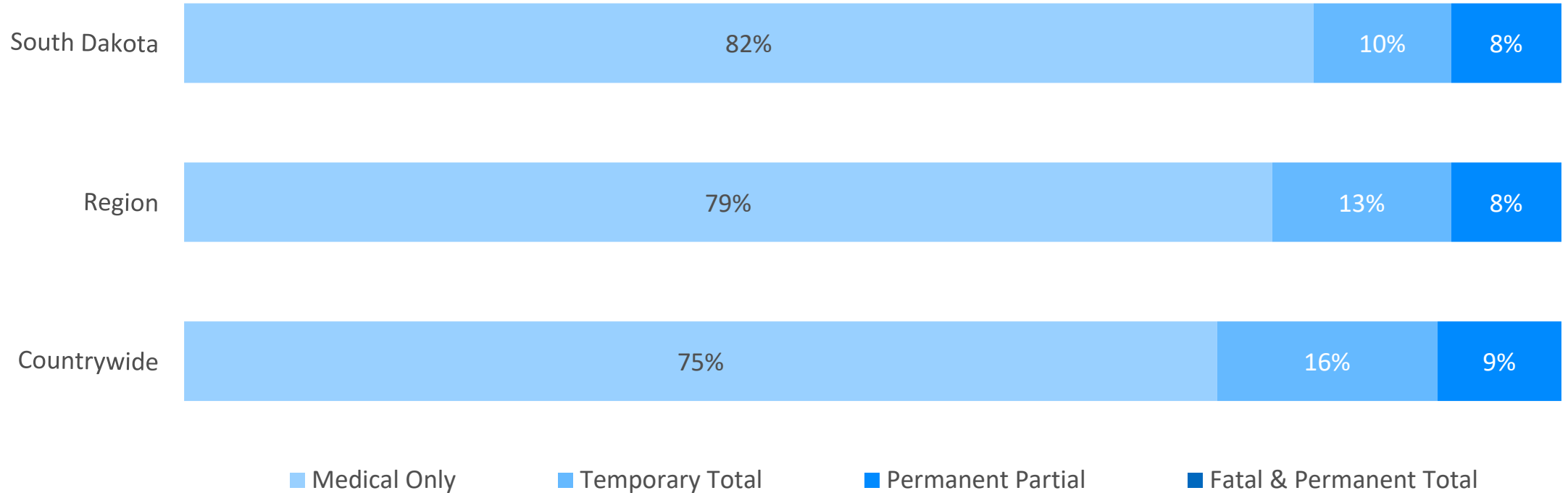
Average Medical Claim Severity in the Region

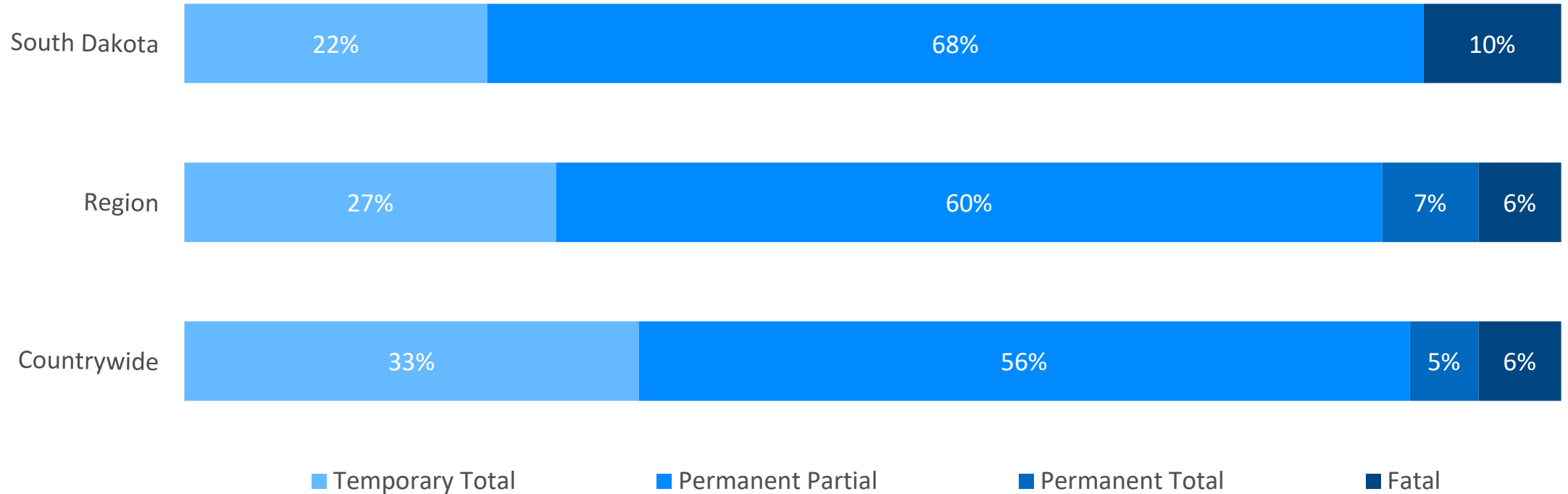
South Dakota Distribution of Claims by Injury Type

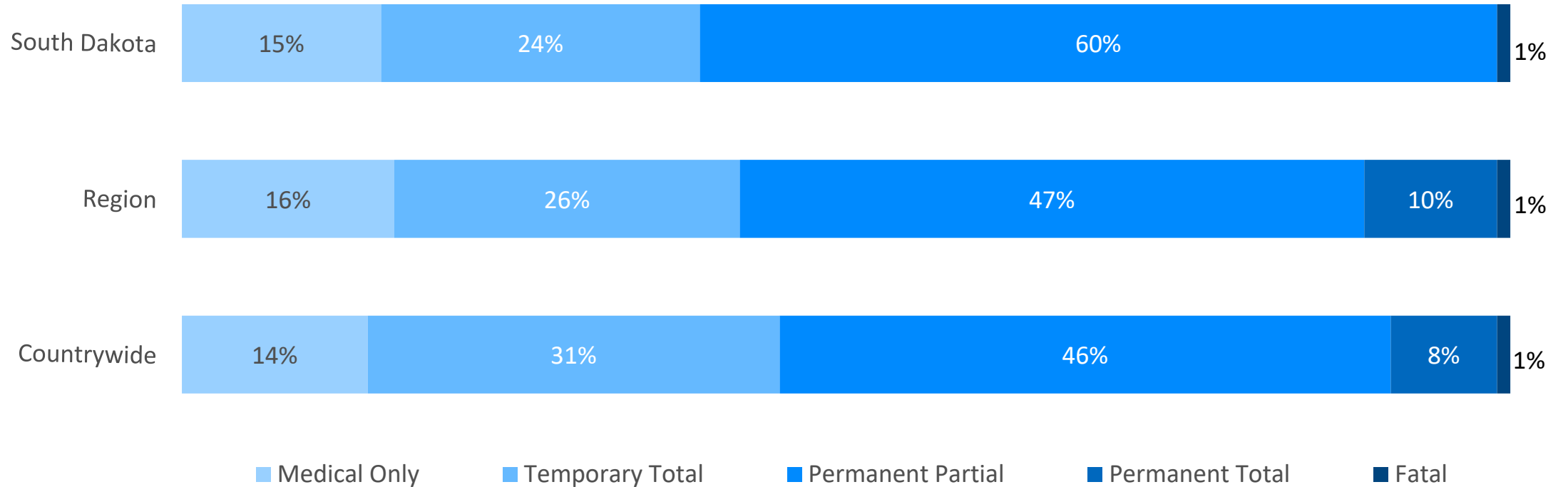
South Dakota Indemnity Loss Distribution by Injury Type
