Texas—Approval of Item 01-TX-2013—Establishment of Texas Notification Endorsement of Pending Law Change to Terrorism Risk Insurance Program Reauthorization Act of 2007

**ACTION
NEEDED**

This circular announces the approval of Item 01-TX-2013—Establishment of Texas Notification Endorsement of Pending Law Change to Terrorism Risk Insurance Program Reauthorization Act of 2007. Please review the proposed changes outlined in this circular for impact on your company’s systems and procedures.

A participating company must submit a reference filing to adopt Item 01-TX-2013, and receive approval from the Texas Department of Insurance (TDI). The TDI requests a TDI file number or link/reference number for reference filings. For Item 01-TX-2013, the TDI file number is 9212557779 and the link/reference number is 129716.

The following basic filing requirements are based on statute, regulation, or common practice and apply to all company filings of a nonstandard endorsement.

Rate, rule, and form filings may be submitted via SERFF (System for Electronic Rate and Form Filing). SERFF allows insurers to obtain state approval by submitting policy rate, rule, and form filings electronically. The evaluation, review, and approval process is also completed in this electronic environment.

Permission is granted to all writers of workers compensation and employers liability insurance in Texas to use the Texas Notification Endorsement of Pending Law Change to Terrorism Risk Insurance Program Reauthorization Act of 2007.
