The ownership determination uses the combination involving the 10 companies controlled by Becky and Alexandra (the purple group).

In addition, two of the entities—SoBe Grill Corporation and Southwest Cooks Corporation—are combinable with each other based on the ownership of the six individuals (the orange group). The other two entities— Elizabeth Concessions Inc and Ballpark Concessions Inc—are combinable based on the ownership of Donna and Becky (the green group). These four entities are not part of any other combination.
