What Is Medical Call Data?

Medical Call data is the bill detail that comes from medical services rendered. The data includes all medical transactions associated with workers compensation claims.

What Is Medical Call Data Used For?

NCCI collects Medical Call data to support legislative pricing focused on medical benefits. The data collected may also be used for research projects approved by the Medical Data Call Research Committee.

Legislative pricing activities include:

- Evaluation of changes to medical fee schedules and other medical-related legislative changes
- Retrospective analysis of recently enacted medical fee schedule changes

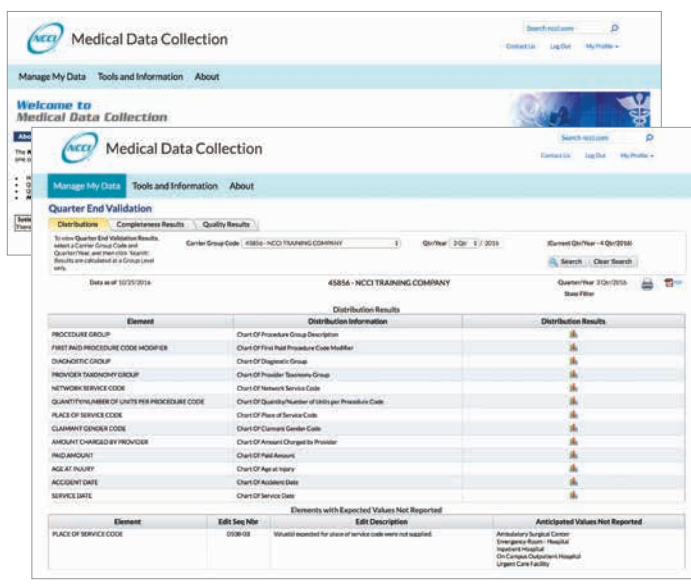
Approved research studies include:

Tools for Reporting and Monitoring

NCCI offers a variety of tools on ncci.com to help you conveniently report and monitor your Medical Call data.



Medical Data Collection allows you to monitor medical submissions and the quality of your data by submission and quarter.

- **Medical Data Collection** enables you to report and view the status of your Medical Call data submissions to NCCI. This tool also allows you to monitor the quality and completeness of your submissions from receipt through each level of editing, as well as your **Medical Incentive Program** results. Additionally, you may generate a report of your search results.
- **Data Transfer via the Internet (DTVI)** is NCCI's Web-based tool for reporting your data electronically. This tool also allows you to receive your data files.
- **Data Manager Dashboard** provides you with a view to the **Carrier Data Quality Report Program (Carrier Report Card)**, which includes the Medical Addendum. This addendum provides you with your company's Medical Call data reporting results.
